IMPORTANT INFORMATION
FOR UNREPRESENTED PARTIES AND POTENTIAL PARTIES

By filing pro se, you have elected to represent yourself and act as your own attorney. **YOU ARE SOLELY RESPONSIBLE FOR COMPLYING WITH THE LAWS OF THE STATE OF GEORGIA AND FULFILLING YOUR RESPONSIBILITIES AS A LITIGANT. IF YOU FAIL TO DO SO, FINAL RESOLUTION OF YOUR CASE WILL BE DELAYED AND THE COURT MAY NOT BE ABLE TO GRANT YOUR RELIEF. MISTAKES MAY RESULT IN ADDITIONAL FEES.** Courthouse or Judge's Office personnel CANNOT assist you. Courthouse staff cannot explain the meaning of a specific rule, interpret case law, explain the result of taking or not taking an action in a case, answer whether a claim has been properly filed, or provide advice on the best procedure to accomplish a particular objective. **IF YOU HAVE ANY QUESTIONS REGARDING YOUR CASE, YOU SHOULD CONSULT AN ATTORNEY.**

Required Documents – Adult Name Change

Required Documents – Minor Name Change

*Notices for name changes must be published within 7 days. It is the litigant's responsibility to be aware of this requirement, any deadlines the newspaper has, and ensure that their Notice is published as required by law.

Notices of Publication should be submitted to the newspaper IMMEDIATELY.

The sufficiency of your petition can only be determined by a Superior Court Judge. If you fail to submit the above documents or your documents are incomplete, inconsistent, or otherwise inadequate, **RESOLUTION OF YOUR ACTION WILL BE DELAYED. IF YOU HAVE QUESTIONS OR UNCERTAINTY REGARDING ANY OF THE ABOVE DOCUMENTS, YOU SHOULD CONSULT AN ATTORNEY.**

After you have filed your case, you may contact the office of the Judge assigned to your case to request a hearing, as listed below.
